

# Cremation Burials

When arranging for a cremation burial at Oak Ridge Cemetery please keep in mind the following things:

1. Call Oak Ridge Cemetery at 217-789-2340 to verify that permission has been obtained for the burial of the individual.
2. A **complete and signed** Interment Record is the only way to reserve the date and time for the burial you would like to schedule.
  - a. The **length, width, and height** of the urn is required. We cannot prepare the ground for burial without the required dimensions.
  - b. The material the urn is made of must be on the Interment Record. Oak Ridge can only bury plastic, metal, and rock urns in the ground without a vault.
    - i. If your urn is made of wood, ceramic, or glass you will need to either:
      1. Purchase an urn vault through Oak Ridge Cemetery for \$140.
      2. Purchase your own vault through Amazon, Google, or somewhere else.

3. A licensed Illinois Funeral Director **must be** present at the burial. The funeral home name must be on the interment record when you send it in to reserve your date and time.

4. A burial permit, certificate of cremation, or a transit permit must accompany the ashes. These can be obtained from the funeral home where the cremation was done.
5. The cost of the burial of ashes (inurnment) depends on the date and time of the burial. The least expensive time to bury ashes at Oak Ridge Cemetery is Monday – Friday between 8 a.m. -12 p.m. for \$650.
  - i. Additional charges are as follows:

Inurnment of cremated remains - weekdays in gates by 12:00 p.m. ....	\$650
Inurnment of cremated remains - weekdays in gates by 1:00 p.m. ....	\$750
Inurnment of cremated remains - weekdays in gates by 2:00 p.m. ....	\$850
Inurnment of cremated remains - weekdays in gates by 3:00 p.m. ....	\$950
Inurnment of cremated remains - Saturday in gates by 12:00 p.m. ....	\$1,150
Inurnment of cremated remains - Saturday in gates by 1:00 p.m. ....	\$1,450
Inurnment of cremated remains - Saturday in gates by 2:00 p.m. ....	\$1,750
Inurnment of cremated remains - Saturday in gates by 3:00 p.m. ....	\$2,050
Inurnment of cremated remains - Sunday/Holiday in gates by 12:00 p.m. ....	\$2,350
Inurnment of cremated remains - Sunday/Holiday in gates by 1:00 p.m. ....	\$2,650
Inurnment of cremated remains - Sunday/Holiday in gates by 2:00 p.m. ....	\$2,950
Inurnment of cremated remains - Sunday/Holiday in gates by 3:00 p.m. ....	\$3,250

6. The burial of ashes on an occupied grave will require the purchase of a second right of burial. The current cost of the second right is \$500. This cost is in addition to the cost of inurnment.
